6. Accidental release measures

Spills & Disposal

Wear appropriate personal protective equipment and clothing to avoid exposure. Extinguish or remove all sources of ignition and stop leak if safe to do so. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Place inert non-combustible absorbent material onto spillage. DO NOT use sawdust. Use clean non-sparking tools to collect the material and place into suitable labelled containers. Dispose of waste according to federal, Environmental Protection Authority and state regulations.
